MEMORANDUM OF UNDERSTANDING IN BETWEEN TOYAMA PREFECTURAL UNIVERSITY, JAPAN REPRESENTED BY ITS PRESIDENT AND ANDHRA UNIVERSITY, INDIA REPRESENTED BY ITS REGISTRAR

- I. **Purpose**
Through this Memorandum of Understanding ("MOU"), Toyama Prefectural University ("TPU"), Japan and Andhra University ("AU"), India intend to establish a mechanism to facilitate and develop opportunities for academic and educational exchange. Neither party shall, at any time, disclose to any third party any confidential information about the other party, which is acquired during activities under this MOU, without the prior consent of the other party in writing.
- II. **Academic and Educational Exchange**
A. TPU and AU desire to encourage academic and educational exchange through:
- (1) Visits by faculty and students from one university to the other for the purpose of consultation, in research or other educational activities.
 - (2) The enrollment of qualified students from one university in undergraduate and graduate programs at the other university.
 - (3) Conducting joint or collaborative research.
 - (4) A sharing of academic publications and scholarly information; and
 - (5) The promotion of other academic activities which enhance the above - mentioned goals.
- B. Both universities acknowledge that visits, if any, by faculty and students from one university to the other shall be subject to the entry and visa regulations of Japan and India and shall comply with the regulations and policies of TPU and AU.
- C. Both universities understand that all expenses, if any, including research materials, tuition, international and domestic travel, per diem, honoraria and all other costs, shall be the responsibility of and shall be borne by the sending university or the visiting faculty or enrolling students. However, the host university is encouraged to seek ways to help visiting faculty and students whenever possible.
- III. **Responsibility for this MOU**




- IV. **Effective Date and Duration**
This MOU will be operated for 3(Three) years following the last date of signature below, unless earlier terminated as provided below or extended by a written amendment signed by both universities.
- V. **Termination**
Either university may terminate this MOU without penalty or liability by giving 3(Three) months' written notice of its intent to terminate to the other university. The termination of this MOU shall not affect the implementation of activities that have been undertaken prior to such termination, unless agreements pertaining to such activities explicitly provide for such termination by both the parties.
- VI. **Governing Law / Arbitration / Venue**
This MOU shall be governed by the laws of Japan and India. Any dispute between the parties shall be resolved by mutual discussions. Any unresolved dispute shall be subject to arbitration under the laws of the respective country having jurisdiction over the conduct and consequences giving rise to the dispute. The language of the arbitration shall be Japanese and English, and the decision of the arbitrators shall be final and binding on the parties. The venue of Arbitration shall be Toyama City or Visakhapatnam, depending on the place where the act and result of the unresolved dispute occurred. The parties irrevocably waive any action or proceeding regarding this MOU to the exclusive jurisdiction of their respective Courts to the extent necessary for an early resolution.
- VII. **Nonbinding Effect**
This MOU is a statement of the current intent and understandings of the participants and is not a binding or legally enforceable agreement. This MOU does not grant any rights to or impose any duties or obligations upon either participating in university. This MOU may not be relied upon as a basis for contract by estoppel or serve as the basis for a claim based on detrimental reliance or any other theory.
